2. Girls Team Projections

- Girls tryouts have started and there have been changes in the number of players in some age groups. SP has made recommendations for the number of teams, and the size of teams, based on current numbers.

➤ Girls U11:

- o Local/returning registrations: 28 skaters and 2 goalies.
- Permission to tryout: 3 skaters

Recommendation: Tier 1 team takes 15 skaters and a goalie which would leave 15 skaters and a goalie for the 2^{nd} team.

NC made a \underline{motion} to accept the recommendation of the Tier 1 team taking 15 skaters and one goalie. 2^{nd} by JS. Carried.

➤ Girls U13:
